PRIVACY RELEASE

Declaration to be made by the Athlete

Pursuant to art. 13 of the Privacy Code and pursuant to art. 13 of the European Regulation 679/16 or GDPR we inform you of the following:

1. the data collected are used exclusively to carry out the services requested by users for the LA GRANDE CORSA BIANCA event such as: preparing the list of participants, the ranking and the historical archive; providing the services declared in the regulation, sending information or advertising material.
2. By registering, the athlete expressly authorizes the organizers, together with the media partners, to use still or moving images that may portray him/her during his/her participation in the event LA GRANDE CORSA BIANCA and related collateral events, on all media, including promotional and/or advertising materials, throughout the world and for the entire maximum time allowed by the laws, regulations, treaties in force, including any extension that may be made to the expected period.
3. All data is processed electronically and is used through mechanical operations necessary to perform the requested services, including the modification and deletion of data by the owner.
4. The data is not transferred to anyone. However, it is accessible by the technical staff appointed by the Organization of LA GRANDE CORSA BIANCA in order to guarantee adequate maintenance and carry out any operations requested by the legitimate owners of the recorded data.
5. The data owner has the right to obtain confirmation of the existence or otherwise of personal data concerning him or her, even if not yet registered, and their communication in an intelligible form. In particular, he or she has the right to obtain information on: the origin of the personal data; the purposes and methods of processing; the logic applied in the processing carried out with the aid of electronic instruments. Furthermore, the data owner has the right to obtain: the updating, rectification or, when interested, integration of the data; the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those whose retention is not necessary in relation to the purposes for which the data were collected or subsequently processed; certification that the modification and cancellation operations have been brought to the attention, also with regard to their content, of those to whom the data were communicated or disseminated, except in the case in which such fulfillment proves impossible or involves the use of means manifestly disproportionate to the right protected. Furthermore, the data owner has the right to object, in whole or in part, for legitimate reasons to the processing of personal data concerning him/her, even if pertinent to the purpose of the collection. In any case, the data will not be used for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication.
